The conversation cuts deeper than signboards and menus; it touches on employment, access, and cultural assertion in one of the country's most dynamic states. This agenda unpacks the fragility and friction that language-based policies create in a nation built on plurality.

Simultaneously, a new storm brews beneath the polished promises of justice reform. With the introduction of amended criminal laws, particularly the sweeping powers conferred by the Bharatiya Nagarik Suraksha Sanhita (BNSS), concerns of unchecked police authority and systemic abuse have taken center stage. The streets tell a sobering story of overreach, intimidation, and victims left voiceless in procedural fog. This agenda demands a hard look at the fault lines between security and civil liberties, and whether reforms meant to modernize law are instead silencing justice.

Agenda 2: Deliberating upon the proliferation of Police harassment in India after the implementation of the new criminal laws with special emphasis on amendments to the BNSS providing special powers to the Police officers.
